MEMORANDUM CIRCULARS

Electric Power Situation

Since the power breakdown which occurred in the early morning of Wednesday, April 22, 1973, the University has taken a number of steps to restore as fully as possible the power service to the community.

The repair of the damaged transformer of the U.P. sub-station will take about 45 days. A temporary replacement has been obtained from Meralco but this delivers only about one-third of the power requirement of the campus. The University has acquired a number of generators to increase the power supply and about 60% of the power needs of the community can now be met.

quisition of other generators to meet the total power requirement.

Meanwhile, Meralco has been requested to present a proposal whereby it will take over from the University the operation and maintenance of the electric power distribution system on the campus.

Until full power is restored the following schedule of power interruptions will be observed:

Time	Areas
From 8:30 a.m. to 1:00 p.m. and 6:00 p.m. to 8:00 p.m.	Area 1, Area 2 and Area 3
From 12:30 p.m. to 5:00 p.m. and 7:30 p.m. to 9:00 p.m.	Area 11, Area 12, Area 17 and Employees Village

The above schedule will be interchanged weekly. Interruptions in the evening will be optional depending on the load. There might also be some gaps in the schedule due to the turning off and on of power in the transformers servicing the different areas.

Furthermore, to avoid overloading of the temporary sub-station, thereby causing another power breakdown, all are requested meanwhile to refrain from using air conditioners, ranges and other similar appliances.

Use of Official Vehicles

Drivers of official cars and other vehicles should be enjoined that at the end of every working day, these vehicles should be brought to the garage in the Physical Plant Office or to other authorized places, secure and guarded, inside the campus. MEMORANDUM

Incentives for Faculty Members to Accept Appointments in External Units

The Board of Regents, upon the recommendation of the President, in order to strengthen the faculties of the external units, and hasten their development into viable autonomous universities, approved at its 833rd meeting on 23 May 1973 the grant of a special allowance in addition to basic salary, to members of the faculty in the Diliman, Manila or Los Baños units, who will accept short or long-term appointments to the units in Baguio, Iloilo, Cebu and Tacloban City.

The special allowance shall be equivalent to 20% of the basic salary. In addition, the University shall provide a resettlement allowance and pay the cost of transportation for the faculty member's family.

First priority is given to faculty members who will handle undergraduate courses in the natural and social sciences and the humanities in U.P. at Cebu and U.P. at Tacloban.

FELLOWSHIPS, SCHOLARSHIPS AND GRANTS

The Board approved the rules to govern the integrated foreign scholarship program of the University:

1. Preference shall be given to nominees of foreign governments or embassies, specially those covered by treaty obligations;
2. Previous scholastic performance which will indicate the applicant's ability to carry on academic work in the University of the Philippines. Transcript of academic records and letters of recommendation from at least three former teachers must be submitted;
3. Must satisfy the entrance and qualifying requirements of the University of the Philippines;
4. Non-English speakers must have taken the Test of English as a Foreign Language (TOEFL), preferably in their respective countries;
5. Financial need will be considered but an applicant must submit a certification from his family or a sponsor that they/he could support him in case he loses the scholarship.

B. To maintain the scholarship, a recipient must carry the normal load prescribed by his academic unit, and must pass all his academic subjects with a weighted average grade of at least "2.75" in the undergraduate and "2.0" in the graduate program.

C. Scholarship lost due to academic reasons may be recovered in the semester immediately following two successive semesters when the student obtained at least a weighted average grade of "2.75" (for undergraduate students) or "2.0" (for graduate students). In case the scholastic delinquency is not due to academic inadequacy, the Office of Student Affairs, after a thorough evaluation of the case, may allow the scholar to retain his scholarship.

COLLECTION OF FEES

The Board authorized the University Computer Center to charge students enrolled in courses requiring computer services a fee of ₱2.00 per computer run beyond three (3) free computer runs per machine problem.

The collection of a fee is believed more equitable than charging a flat rate of ₱20 per student, inasmuch as the rate is based on need or frequency of use.

The Board approved the increase in laboratory fees in the College of Engineering from ₱11.50 to ₱17.50 per laboratory course, effective the first semester, 1973-1974, provided that this will not be subject to the 20% general increase in all fees to take effect the first semester, 1973-1974. The cost of materials has gone up considerably, hence the increase.

The Board approved the increase in laboratory fees for the Department of Veterinary Anatomy in the College of Veterinary Medicine effective the first semester, academic year 1973-1974, from ₱11.50 to ₱17.50 per laboratory course (which is the standard laboratory fee in the College of Arts and Sciences), provided this will not be subject to the 20% general increase in all fees to take effect the first semester, 1973-1974.

The above increase is made for the following reasons:

a. The prices of laboratory animals have gone up due to their scarcity and their being used as food and working animals.

b. The prices of chemicals, reagents and other laboratory supplies have correspondingly increased due to the floating rate.

The Board likewise approved the adoption of the following schedule of fees for the graduate program in the College of

Veterinary Medicine, beginning with the first semester, 1973-1974:

Tuition fee	P 30/unit
Miscellaneous fee	P123 (standard)
Laboratory fee	P 17.50/subject (standard) *

* Not subject to the 20% general increase in all fees to take effect the first semester, 1973-1974.

CHANGE OF NAME OF BISLIG BAY LUMBER CO. PROFESSORIAL CHAIR IN BUSINESS ADMINISTRATION

The Board approved the change of name of "Bislig Bay Lumber Co. Professorial Chair in Business Administration" to "Paper Industries Corporation of the Philippines Professorial Chair in Business Administration" effective January 1, 1973.

The change is in accordance with the merger of the Bislig Bay Lumber Co. Inc. with the Paper Industries Corporation of the Philippines (PICOP) on June 1, 1972. PICOP has indicated its willingness to continue funding the chair previously supported by Bislig Bay.

UPGRADING AND ALLOCATION OF CLASSES IN OFFICE OF ADMINISTRATIVE PERSONNEL SERVICES

The Board approved the upgrading of the class Military Assistant from Range 3 to Range 5 and the allocation of the class Electrician to Range 5 in addition to the existing allocation of Ranges 3 and 4.

GRANT OF ACADEMIC RANK TO FACULTY MEMBERS OF UNIVERSITY ELEMENTARY SCHOOL

The Board approved the grant of academic rank to faculty members of the University Elementary School, as in the case of faculty members of the University High School.

The Board noted that according to records, many of the Elementary School faculty have been teaching undergraduate and graduate courses continuously. While a few have not yet engaged in college teaching, it is planned to let them handle college courses during the coming semesters. Further, the Board noted that faculty members of the Elementary School are as academically prepared as those in other units. As of now, 35.4 per cent of the teaching staff have already earned their Master's degree and some are presently working on their post-graduate program.

ESTABLISHMENT OF UNIVERSITY OF THE PHILIPPINES AT TACLOBAN

The Board accepted the proposal from the Provincial Government of Leyte for the establishment of a branch of the Univer-

sity of the Philippines at Tacloban effective the first semester, 1973-1974, to be funded by the Provincial Government of Leyte by providing one million pesos (P1,000,000) in lump sum, plus P150,000 for the first year of operation. This would be in addition to (a) a site, (b) Marcos pre-fabricated buildings, and (c) the provincial capitol building to be made available to the University by the provincial government of Leyte.

In this connection, the Board approved the budget for the branch covering an outlay of P444,270, chargeable to the one-shot contribution of the Province of Leyte in the total sum of P1,150,000 and the income from student fees of the unit.

In order to guarantee the continuous operation of the branch, the National Government shall be requested to provide the future funding for this unit, just like for the other outlying units.

INCENTIVES FOR FACULTY MEMBERS TO ACCEPT APPOINTMENTS IN UNIVERSITY EXTERNAL UNITS

The Board approved incentives for faculty members to accept appointment in external units of the University by providing them a special allowance equivalent to 20% of their regular salary plus a resettlement allowance and the cost of transportation for members of their families.

ESTABLISHMENT OF THREE DEPARTMENTS IN COLLEGE OF SCIENCES AND HUMANITIES

The Board approved the establishment of three departments in the College of Sciences and Humanities, University of the Philippines at Los Baños, namely: Botany, Zoology and Life Sciences.

The departments of Botany and Zoology, with a combined complement of twenty-two faculty members, will specialize in the study of the unique characteristics of plant and animal life.

On the other hand, the Department of Life Sciences, with an initial complement of sixteen faculty members, will oversee the integrative approach to the study of life, and will take care of the disciplines of biology (molecular, cell, and biophysics), genetics, microbiology, systematics, ecology, and environmental management. It will also be responsible for offering the General Education biology courses and coordinating the B.S. Biology curriculum.

HISTORICAL PAPERS AND DOCUMENTS

A NEW ACADEMIC CONSTELLATION—THE UNIVERSITY OF THE PHILIPPINES SYSTEM

(Remarks at the First Meeting of the University Council of the University of the Philippines at Los Baños, Monday, May 21, 1973)

I have come to this historic first meeting of the University Council of the University of the Philippines at Los Baños for two reasons: first, to underline the need to maintain essential links between this first autonomous University and the University of the Philippines System; and second, to consider some of the principles that should govern henceforth the relationship between the System and the member universities.

A special responsibility rests upon the University of the Philippines at Los Baños. Its administration and operation will, to a large extent, set the pattern for the future development of the System and its component units. By the terms of Presidential Decree No. 58 issued on November 20, 1972, and the resolution of the Board of Regents adopted on December 21, 1972 in implementation of the decree, the University of the Philippines at Los Baños was established as a distinct and separate institution enjoying a substantial measure of autonomy in academic, administrative and fiscal matters under the authority of the Board of Regents and the President of the University.

It is perhaps natural at this initial stage of the development of the System that there should be a tendency to emphasize the linkages that exist between the System and this autonomous University rather than the features which endow the University with a distinct and separate personality.

While this may seem at first sight to constrain the autonomy of this University, the tendency in the future will be to expand rather than to diminish this autonomy. This is as it should be. It follows from this principle that the powers of the Chancellor and the other organs of the University here will tend to increase with the passage of time, and I give you my pledge not only to allow but to encourage this inevitable development.

Meanwhile, I believe you would agree that at this initial stage it should be our common concern to emphasize the integrity and unity of the System as a whole so that each autonomous member University, while developing its own potential according to its own needs and circumstances, will find its proper place in the academic constellation known as the University of the Philippines System.

You will see from this that we, all of us together, bear a heavy responsibility: I as the first President of the University of the Philippines System, Dr. Samonte as the first Chancellor, and you as the Faculty of the first autonomous University of the System. The circumstances under which the decision was made to establish a System of autonomous universities rather than a separate and independent Agricultural University at Los Baños serve to underscore the weight and magnitude of this responsibility. You will recall that the decision was taken at the end of a long and exhaustive discussion in the course of which ideas and proposals were advanced and sustained with a vigor and earnestness appropriate to a community of scholars. Now that the decision has been taken, we have a right to expect all members of the community to cooperate loyally in its implementation.

The gravity of the problems we have to face together is compounded by the very nature of this University itself. The Los Baños units have long occupied a special, nay, a unique role in our scheme of national education. Here is the heart and center of the agricultural and forestry sciences in our country, and here, therefore, is a vital command post of the national economic development program in general and of the food production program in particular. Without relinquishing this special character and responsibility, Los Baños must now assume an added task, that of transforming itself into a rounded, complete and balanced University, offering comprehensive, quality education in the natural sciences, social sciences and the humanities. The effort to achieve this objective will require a great deal of time, energy and resources, but it is an essential task that must be done. I am certain that the achievement of this objective will enhance rather than diminish the stature of Los Baños as one of the nation's principal institutions for the development of our natural and human resources.

In the face of the special problems of this new University, it was our view in the Board of Regents that this University would be best served during this initial stage by appointing as the first Chancellor of the University an outstanding academic personality with proven expertise and experience in the field of university administration. Accordingly, the Board of Regents upon my recommendation decided to appoint as the first Chancellor of this University, Dr. Abelardo G. Samonte, the former Vice-President for Academic Affairs.

I will not say anything at this time in praise of Dr. Samonte. If he expects your high regard he will have to merit it, and if he craves your support he will have to earn it. All I can say at this time is that he has the confidence of the Board of Regents and that we commend him to your undivided support and cooperation. He has the ability, earnestness and commitment to accomplish the task entrusted to him, namely, to establish in Los Baños a University worthy of the traditions of the University of the Philippines, an institution that will set the standards for other autonomous universities to follow.

As President of the University System, it is natural, I repeat, that I should stress the unity and the integrity of the System. One of the unifying principles of the System is the principle of the interchangeability of personnel, the mobility of professors and administrators throughout the System, from one member university to another. This principle is not new; it is really quite old, and is perhaps best exemplified by the man who held longest tenure as President of the University of the Philippines and is remembered as one of the most effective presidents the University ever had, a man of Los Baños, Dr. Bienvenido M. Gonzalez. Just as Los Baños once sent one of its outstanding sons to Manila and Diliman to run the University, so now we return the compliment by sending to Los Baños an outstanding son of the University from Diliman. Thus, the wisdom of the principle of interchangeability and

mobility of personnel will be proved once more, to the benefit of the University as a whole.

In closing, I would like to draw for you a projection of the University of the Philippines System that is yet to be. Los Baños is the first of the autonomous Universities. The Board of Regents has decided to give a chance to the other existing external units in Baguio, Iloilo and Cebu to develop into autonomous universities. Tarlac will cease operations this coming academic year, for the reason that it has failed to grow and develop. We are considering the establishment of a third external unit located in Tacloban City to cover the eastern region of the Visayas. We also believe that Mindanao should have at least one branch of the University, located in Davao, because it is unthinkable that our second largest island should be deprived of a University of the Philippines presence.

This, then, is the framework of a System consisting of the core unit at Diliman and Manila, the first autonomous University at Los Baños, and potential autonomous universities in Baguio, Iloilo, Cebu, Tacloban and Davao. This is a project both challenging and exciting, based on the belief that the University of the Philippines should make its presence felt in all the principal regions of the country. Heretofore, external units have been maintained merely to represent a *symbolic presence* of the University of the Philippines. This policy is ended. Unless the external units are able to maintain a *living presence* of the University, they constitute an unjustified waste of precious resources.

This development plan presupposes that the University of the Philippines will become the main provider of quality higher education for our youth. This is the challenge we have to face. None of the small external units will ever have the advantages that Los Baños enjoys in terms of physical plant, facilities, equipment or academic personnel. But to the extent that the national govern-

ment is able to provide them with the resources they need, they will at least have the potential to develop into efficient and viable institutions of higher learning.

This is the vision of the University of the Philippines System that I would like to share with you. It is an exciting vision that is well within the realm of realization. I would like to remind you that even as we are establishing the University of the Philippines System the government is starting a complete overhaul of our system of higher education. With the holding this year of the first National College Entrance Tests we are, in effect, adopting the principle of selective admissions to college and university — the principle that only those should go to college who have the ability and the commitment to benefit from a university education. This will reduce college enrollment and force many colleges and universities to close shop. This, in turn, will create mounting pressure on the University of the Philippines to admit more students.

I do not know what this will require in terms of funding, physical facilities, and faculty. I know only that the requirements will be beyond what the University, with its present resources, is now able to provide. But if the University is challenged to provide more places for deserving students, then I see no option for the University except to respond to the challenge.

This is the reason why it is so important to make a success of this first autonomous University of the Philippines at Los Baños. Its success will point the way for the other autonomous universities that come after. This is the measure of the challenge that is specifically addressed to this University, and I wanted to come to this historic first meeting of your Council to apprise you of the weight and magnitude of our joint responsibility. It is a formidable challenge, but if we stand firmly and loyally together, we shall overcome.

FREEDOM WITH RESPONSIBILITY

(Address delivered at the Commencement Exercises, University of the Philippines, 27 May 1973)

You are the durable members of a class that may have been destined for greatness. You first came to the University or were already here in 1969, the year that ushered in the most turbulent period in the history of the University. Indeed, Class 1973 has the distinction of having survived an apocalyptic quadrennium which encompassed the earthquake of 1969, typhoon Yoling of 1970, and the floods of 1972, as well as the battle of Mendiola of 1970, the barricades of 1971, the suspension of the privilege of the writ of habeas corpus in 1971, and the proclamation of martial law in 1972.

I would like, therefore, to extend my fervent congratulations to you. You complete your studies at a time of fateful transition in the life of our nation. You have been tested, as it were, by the forces of nature and ideology. You have come through, battle-scarred and somewhat chastened, but alive and keenly aware of the mighty winds of change that are sweeping our country today.

The most radical change has come to the universities. Overnight, as if by magic, the University of the Philippines has been transformed into a tranquil grove of academe. The ubiquitous graffiti have disappeared from the walls of the buildings. Classes have not been disrupted or suspended in favor of demonstrations in front of Congress or Malacañang or the Amer-

ican Embassy. Instead of marching in the streets, the students have queued up to enter the library, theatre, gym or swimming pool.

Students have grown quiet but only in the sense that they no longer brandish placards or shout slogans at the top of their voices. While shying away from activism, they have in fact become more active than before. In addition to sports and other extra-curricular activities, students seem to have been doing more reading, more studying and, one hopes, more thinking also than before.

In short, teachers are attending to their teaching and students have gone back to their studies — both with exemplary zeal. The lot of university presidents has also changed for the better. I remember how people used to shake their heads in disbelief and pity when told that in 1969 I gave up the two most prestigious ambassadorships in our foreign service — the United Nations and Washington — for the presidency of this University, thus exchanging the soft and sybaritic life of a diplomat for the tough and dangerous life of a university president. Today, people have stopped commiserating with me, for the life of a university president has become not merely tolerable but rewarding and, with luck, even pleasant and enjoyable.

The universities have become quiescent rather than quiet. The distinction is important. One should not assume that they have been struck dumb by martial law, for the classrooms, libraries and laboratories are inviolate havens of thought, and fear cannot long constrain the human mind. One must rejoice that this is so, because a university that has lost its kinetic force and become as silent as a cemetery has lost the right to be called a university.

It would therefore be misleading to say that the universities have subsided into a state of total paralysis since martial law. In fact, they are humming with more activity than before, though this is the more meaningful activity of the mind and the more salutary activity of the body. We are, in effect, returning to the simple, traditional wisdom embodied in the ancient motto: *mens sana in corpore sano*.

There is an enduring element of traditionalism at the core of all radical philosophy. After all, a radical is perhaps best defined as one who goes to the roots of things. Accordingly, the type of radicalism most appropriate for our time is one that has the courage to suspect and if necessary reject dubious ideas or values whose main attraction is that they are new, as well as the wisdom to hold on to tested ideas or values whose only fault is that they are old.

The paradox of the New Society is that it aims at the restoration of the traditional values of Filipino society which the modern, urbanized Filipino has come to regard as old-fashioned, outmoded and rather quaint. It calls for the reconstruction of Filipino society by using as building blocks the ancient virtues of our forefathers: individual dignity, social discipline, obedience to law, rights counter-balanced by responsibility, respect for the rights of others, honesty, industry, patriotism, etc.

The New Society thus re-emphasizes old traditions and tested values. What is new in the New Society is the insistence that our people have the courage and ability to correct the evils that have long plagued Filipino life: the greed and selfishness, the graft and corruption, the irresponsibility and anarchy, the crime and violence — evils which we have tolerated as inevitable and accepted as the necessary concomitants of a system based on freedom and democracy.

Already we see evidence of dramatic improvements that have come about in a period of only eight months since martial law. Laws are being enforced, government employees are more honest and efficient, taxes are being paid, irresponsible politicians have been immobilized, the streets are cleaner and safer, everybody is home before midnight, and people seem to be more considerate of each other. More important than these is the primacy given to a national program of economic and social development which aims at the more equitable sharing of the bounties of life among the people, thus narrowing the abyss that separates the affluent few from the impoverished majority of our people. One aspect of this program is the concentration of effort and resources on agricultural and industrial production; another is the launching of agrarian reform on a nation-wide scale.

But the changes in our society are yet new and fresh; it will take time for the reforms and improvements to take root and become permanent. The threat of backsliding is real, and we see signs of such backsliding even now. Our society, which has been sick for a very long time, has just passed through a dangerous crisis, and is on the way to recovery. But this is precisely the moment when the threat of a relapse is greatest—a relapse that could lead to mortal danger.

Time, then, is what the New Society needs. How much time? This is a matter of careful appreciation of the realities. On the one hand, the reforms need time to take deep root so that

the process of amelioration becomes irreversible. On the other hand, this is truly a nation conceived in liberty and dedicated to the principles of freedom. It is hardly necessary to recall that the numerous tribes of this archipelago were forged into one nation in the fire of a prolonged struggle against Spanish rule that lasted more than three centuries, or that we finally earned the right to liberation in 1946 because we had resisted the American occupation of 1898 as well as the Japanese invasion of 1942.

In proclaiming martial law and instituting the New Society, President Marcos could not have desired or intended to uproot love of freedom from the heart of the Filipino or to extinguish the flame of liberty that burns in his soul. That would be an impossible task, and as one of our most distinguished heroes of the last war he surely knows better than to attempt it. I believe that what he wants done, and what we should all try to do together, is to fashion a way of life carefully balanced between freedom and responsibility, between liberty and order. Our task is to achieve freedom with responsibility, liberty with discipline, order without regimentation, authority without tyranny, that is, a viable compromise between the integrity of individual life and the necessities of collective existence—and to achieve this without the violence and bloodshed that usually attend such revolutionary enterprises.

We are running a race with catastrophe. For it is far easier to lose freedom without bloodshed than to regain freedom without bloodshed. One should never assume that a people willing to sacrifice freedom and democracy for the sake of necessary reforms are prepared to bear the sacrifice indefinitely. Quiescence is not necessarily synonymous with tranquility, nor acquiescence with affirmation. The crucial problem, therefore, is to determine the precise point at which the sacrifice ceases to be supportable and grievances become explosive—the point, in other words, at which the restitution of civil liberties and the restoration of representative government become imperative.

Let no one deny it: our political system, our economic system, indeed, the national society as a whole has required the double therapy of deep purgation and shock treatment. But such radical therapy is not without danger, and care must be taken to ensure that the deep-seated vices are eradicated without, however, killing the patient.

The proper timing of a return to constitutional government is a crucial decision which rests solely on the judgment of the President of the Republic. Montesquieu pointed out long ago that no government can long rest upon the isolation, through mutual fear or suspicion, of the ruler from the ruled or of the citizens from each other. Such a government, he said, would negate the essential condition of all forms of political organization, namely, the need of the ruler and the ruled, and of the citizens among themselves, for acting and speaking together. President Marcos, in his political testament, *Today's Revolution: Democracy*, which was published in September 1971, one year before martial law, expressed a similar thought in these words: "Political power in a democracy is responsible power. Because government and people are joined together by the principle of consent, the political authority is, therefore, accountable to the people; it is an authority that must explain itself."

These considerations would seem to argue in favor of the restoration of civil and political rights sooner rather than later.

The New Society is facing its most difficult test in the universities. For in the universities are to be found the most intelligent and sensitive groups in the national community; it is there where human thought cannot be unchained, where the life of the mind cannot be constrained by diktat. If the New Society

passes the test in the universities, it means that the most sophisticated and critical segment of the population has accepted the regime and is willing to adjust to it as an unavoidable way-station on the road to a more humane, more just, more equitable society. This would be the beginning of our national redemption.

If this should come to pass, our children in after years will arise to call us blessed. They will call us blessed because in the time of darkness we waited to see the light, and in the day of anger we held our peace.

But, today, if we acted out of misdirected courage, misguided

will, or erratic vision, then we would be a nation doomed, and the only destiny that would await us is measureless sorrow, agony and death.

If, on the other hand, we responded positively to the challenge of the present, then we would be helping to build a new society imbued with the dreams of our heroes and capable of providing a better life in larger freedom for all our people.

This is the challenge we must face together. God grant that we may have the wisdom, the will, and the courage to do our part.
